- 6.2 If Cozumel Dive School in Cozumel, Mexico is unable to resolve a serious complaint, and the Individual leaves the Program before the completion date, the Individual shall provide the Program Host with a written version of events.
- 6.3 No compensation shall be given to the Individual, unless there are extreme circumstances, which shall be determined at the sole discretion of Cozumel Dive School. The Individual agrees that under no circumstances shall Cozumel Dive School be liable for damages or compensation arising from any claim related to the assessment of inconvenience, disappointment, discomfort or loss of enjoyment.

7. **Property and Intellectual Property**

- 7.1 All equipment and resources provided by Cozumel Dive School both prior to and throughout the duration of the Program (including teaching manuals) remain the property of Cozumel Dive School and must be returned on completion of the Program unless otherwise specified by Cozumel Dive
- 7.2 Individuals shall replace as new any property that is lost or damaged through careless or thoughtless conduct.

8. <u>Data Protection</u>

8.1 It may be necessary for Cozumel Dive School to pass data about the Individual to Mexican government officials. The Individual hereby agrees that Cozumel Dive School may disclose their personal data, including any sensitive personal data, such as relevant medical history, to representatives of immigration, police or other governmental officials in Cozumel, Mexico.

9. <u>Termination and Expulsion</u>

- 9.1 Cozumel Dive School reserves the right to immediately and automatically expel any individual in breach of any term of this Agreement.
- 9.2 Without prejudice to the generality of clause 9.1 above the following will result in automatic expulsion:
 - 9.2.1 Possession / taking / supplying illegal or illicit substances. The question of whether the substances are illegal or illicit is to be governed by the jurisdiction of Cozumel. Mexico:
 - 9.2.2 Displaying cruel, thoughtless or rude conduct or committing acts which could injure or harm a member of the Program (including a staff member), or any other person;
 - 9.2.3 Disobeying Cozumel Dive School, or Mexican official instructions in relation to health and safety;
 - 9.2.4 Committing an act or displaying conduct which could jeopardise future Cozumel Dive School Programs within Cozumel, Mexico or lead to the souring of relations between Cozumel Dive School and the local community or Cozumel, Mexico; and
 - 9.2.5 Breaking local laws.
- 9.3 Expulsion will be carried out at Cozumel Dive School own discretion and is not subject to appeal.
- 9.4 In all such cases the Individual will not be entitled to any reimbursement from Cozumel Dive School, neither will Cozumel Dive School be responsible for any additional costs incurred by the Individual.

10. Currency of Agreement and Cancellation

- 10.1 The Individual will be entitled to cancel this Agreement at any time up until 45 days before program start. In this event, the individual will be entitled to all monies paid less the deposit paid. If the Individual cancels the booking between 45 and 30 days before program start they will be entitled to 70% of all monies paid less the deposit. If the Individual cancels the booking with less than 30 days before program start they will be entitled to 40% of all monies paid less the deposit. Once the internship has started; they shall not be entitled to any money back.
- Individuals will be allowed to transfer their program dates at any time up until 8 weeks before program start. With 8 weeks to program start, a transfer fee of US\$250 shall be applied. With less than 4 weeks to program start a US\$500 transfer fee shall be applied. Any change of placement shall be at Cozumel Dive School discretion. A program can not be transfers more than 1 year beyond the original starting date.
- 10.3 Cozumel Dive School reserves the right to cancel or curtail the Program if, in its absolute discretion, it believes that circumstances warrant it. This shall

include cancellation where there is an event of force majeure which has occurred (see below). In this instance, the Individual shall be entitled to any monies paid less any other irrecoverable expenditure on the part of Cozumel Dive School which has already been spent in relation to the preparation of the Program.

- 10.4 If Cozumel Dive School cancels the Program, the Individual will be entitled to a refund:
 - 10.4.1 in the case of cancellation by Cozumel Dive School before departure, whether within or beyond Cozumel Dive School control, the Individual shall be entitled to their deposit and any monies paid, less any other irrecoverable expenditure on the part of Cozumel Dive School which has already been spent; and
 - 10.4.2 In the case of curtailment, the Individual shall be entitled to a reasonable proportion of the total charge from which any irrecoverable expenditure is deducted.
- 10.5 In all of the above cases where there is a cancellation, Cozumel Dive School first recourse shall be to place the Individual on an alternative placement. Cozumel Dive School shall use its reasonable endeavours to match an alternative placement to suit the Individual's requirements.
- 10.6 In all of the above cases, either party shall give written notice to the other of the cancellation, and any refund or alternative placement given to the Individual shall be considered to be in full and final settlement of all and any liability owed by Cozumel Dive School to the Individual.

11. Force Majeure

11.1 Notwithstanding any other provision of this Agreement, Cozumel Dive School shall not be deemed to be in breach of this Agreement or otherwise be liable for any delay in performance or non-performance of any of its obligations under this Agreement to the extent that the delay or non-performance is due to any circumstances beyond its reasonable control, including but not limited to Acts of God, war, acts of terrorism, riot or civil commotion, fire, strike and government or other official intervention.

12. Acknowledgement of Covid-19 & other diseases risks

- 12.1 Individuals shall be aware of a higher exposure to Covid-19 and other contagious diseases due to the specifics of the scuba diving industry. Participation in the Program means Individuals accept that risk and agree to follow all the health and safety policies, precautions and assessments implemented by Cozumel Dive School, its partners and local authorities. Individuals acknowledge that the aforementioned protocols are aimed to reduce the virus transmission, but they do not completely prevent exposure to Covid-19 and other diseases.
- 12.2 If, at any point during the Program, an Individual shows symptoms of Covid-19 or other contagious disease, or has been in contact with a confirmed case of the aforementioned, they are required to inform Cozumel Dive School Staff, take an appropriate test and self-isolate until obtaining results of the test. If the result is positive, the Individual must self-isolate for the time recommended by a physician and may return to the Program only after showing a negative test result.
- 12.3 In case a self-isolation is required as described in 12.2, if an Individual is staying at Cozumel Dive School accommodations, they shall find a separate accommodation and may return to Cozumel Dive School premises only after showing a negative test result. Cozumel Dive School shall not be held financially responsible for the cost of the aforementioned accommodation.

13. General

- 13.1 This Agreement constitutes the entire Agreement between the parties and shall apply to the Program provided by Cozumel Dive School and undertaken by the Individual.
- 13.2 A person who is not a party to this Agreement has no rights to enforce any term of this Agreement.
